Cash for college assisted 40 students to apply for financial aid.

Crime Stats Year to date: 2013 we had 196 part 1 crime, now year to date we have 130. Homicide crimes are up. Last year this time we had 3. This time year to date we have 6. Overall Foothill crime is down, but we are worried and looking closer to homicides.

Party Call Car will begin this spring to take care of all the party calls in the division. This car will specifically go to the call to the department for parties that are disturbing the peace. Still call dispatch or front desk and they will direct the call to the party car.
