Motion: PNC Board to approve up to \$3,000.00 to be used by the PNC for the planning and execution of Neighborhood Improvement Project on June 7, 2014 from 9:00 am to 2:00 pm.

Project: the creation of a garden on the corner of Remington St. and O'Melveny Ave. Funds will be used to provide food & drinks to event volunteers, purchase 150 custom T-shirts to be given out to participating residents, purchase outreach materials (flyers), table & chair and canopy rental.

IV. (5 min.) Public Safety and Health Committee Chair

Report: recommends the PNC to collaborate with LAPD Jeopardy Program with the purchasing of supplies (equipment and clothes) and to not exceed \$2,000.

Motion: move a city department transfer to LAPD to approve up to \$2,000 for its Jeopardy Program. Funds will assist our Pacoima youth who participate in the Jeopardy Program.

Report: recommends the PNC to collaborate with LAFD Fire Station 98 with the purchasing of equipment ,and to not exceed \$2,000.

Motion: move a city department transfer to LAFD to approve up to \$2,000.

Report: recommends the PNC to approve a Safe Night Out Movie Night at City Hall

Motion: move to approve the Safe Night Out Movie Night. NO Money Involved.

Report: recommends the PNC to collaborate with LAPD for Pacoima National Night Out and to approve and to not exceed \$6,000.

Motion: move to approve a Demand Warrant up to \$6,000 for food, banners, stage, magician, food, and outreach materials LAPD's Pacoima National Night Out Aug. 12th 2014 at Roger Jessup Park.

The Board shall then refer the matter to the Grievance Committee, which shall have 10 working days to meet with the person submitting a grievance and to discuss ways in which the matter may be resolved. The Committee shall prepare a written report for the Board outlining their recommendations for resolving the grievance. The Board must then address the report at the next regular or special meeting. In the event that a grievance cannot be resolved through this grievance process, the matter may be referred to the Department of Neighborhood Empowerment for consideration or dispute resolution in accordance with the Plan. The formal grievance process is not intended to apply to Stakeholders who simply disagree with a position or action taken by the Board at one of its meetings. Those grievances can be discussed at Board meetings. This grievance process is intended to address matters involving procedural disputes, e.g. the Board's failure to comply with these Bylaws, or its failure to comply with the City's Charter, the Plan, or local, state, or, federal law.
