LAPD community relations moving into city hall downstairs. Cadets and foot beat that focuses on business on Van Nuys corridor. Retail space being looked into to put in a computer lab and additional restrooms. Building open for 3 years, this office has been in the building for 9 months. Trying to make more use of the building. Rooms are available for PNC committee meetings, submit request for the space with time and dates. Foothill Division crime is down. Aggravated assault crime has increased this week. Closed home that used to be a squatters home has closed down and the squatters are moving to other areas in Pacoima. Hoyt St. home was closed up and collected a lot of meth being transported from location to location. Call the office if you notice something suspicious, police will check out the location.
