- a. California Congressional District 29 Congressman Tony Cardenas, Field Deputy: None Listed. **Did Not Attend Meeting.**
- b. California State Senate District 18 Senator Bob Hertzberg, District Representative: Eveline Bravo-Ayala. **Did Not Attend Meeting.**
- c. Los Angeles Police Department Foothill Division, Senior Lead Officers: Adriana Munguia **Did Not Attend Meeting** and/or Steve Nuñez **Did Not Attend Meeting**.
- d. Los Angeles City Council District 7 Councilwoman Monica Rodriguez Field Representative: Susana Carmona. She gave updates on Councilwoman's Press Release pushing for full cost of recovery for illegal cannabis enforcement. On April 12th the Councilwoman gave a motion directing the City Attorney to draft an ordinance.

Kelly Gonez attended our meeting with Principal Jose Razo, she arrived to our meeting at 7:30 p.m. Kelly discussed about campuses being over 50 years old and to support Measure EE which will be in special election vote on June 4th, where home owners would pay per square foot a percentage.

Jose Razo, shared it is important that this measure gets voted on and needs this to not keep losing 100-150k annually that keeps getting removed. Stated, that this is very near and dear to his student's to have fair resources for his student's.
