Fair Workweek LA Campaign Support, scheduling in retail stores. Asking community to endorse a resolution of community impact statement directed to LA City council where the Pacoima Neighborhood Council will or will not be in support of the Fair Workweek CIS, where policy is to receive 2 week notice of scheduling and are not forced to work closing, opening or on call shifts, will not be retaliated against for requesting shift changes and will be compensated for last minute changes in schedules.

e. Motion/Discussion/vote/ for the possible approval of CIS, On Metro Transit Proposal- By Faramarz Nabavi (Recommended by Land Use Committee).

Reuben Garcia Motions. Mikayeel Khan Seconds.

Faramarz Nabavi made a presentation regarding the Metro East San Fernando Valley transit project. Metro showed options for community relevant stations. Faramarz states Metro is proposing to make a light rail from Sylmar to the Orange line and Metro is also proposing to make a subway from Van Nuys to the West side. Faramarz proposes to the Pacoima Neighborhood Council that we call on Metro to revisit and look over again at alternatives because what Metro proposes will go from Van Nuys Blvd. to San Fernando which will cause a knock out on many businesses in our community. Faramarz created a Community Impact Statement where Metro is called to revisit and study alternatives to convert a subway extension etc.
