> Officer Nunez, Senior Lead Officer, informed the Council that in the month of April not many changes occurred and we are in the negative 10% crime reduction bracket. The Chevy Silverado is still the car of choice for thefts of catalyst converters and at this time Chevrolet is making a malfunction kit, but the kit is hard to get and that is why this car is so desirable. Old Hondas and Toyota Camry autos are also a target of theft. Richie Valens Park is at stage III on clean-up with Caltrans as the back side is finished. This clean-up effort is a priority.

To date we have distributed over 8,000 in mobile sites in Pacoima. Anyone age 60 and older can get vaccinated, so please contact our office. We still have COVID-19 care kits for anyone in need.

> Ms. Carmona screen shared pictures of Pacoima Beautiful for Earth Day and the clean-up focused along Van Nuys Boulevard and multiple streets in the area. Many streets that have been slurry sealed to strengthen the streets and add aesthetics and longevity. Weed abatement was also performed.

The Bright Spot Program has increased activities and they are picking up bulky items and cleaning streets. Please contact our office if you find illegal dumping or see a need for weed abatement.

We continue to work with Caltrans to clean up encampments and the 5 freeway offramps. The clean-up of the Richie Valens area is continuing and it being partnered with the Fire Department and the Mayor's Office along with efforts to vaccinate individuals in the bridge housing community.

h. <u>California State Assembly District 39</u> Assemblywoman Luz Rivas Field Representative: Brenda Yanez Zamora

Ms. Yanez stated that Los Angeles is moving from the red zone into a less restrictive COVID-19 zoning as of April 5th. Local community activities are

being amended. If you need additional information, please call her office. As of April 16th, vaccinations for the over 60 group is available for all. The age group of 16 and above must be Pfizer so register and pick a location that provides that service. The two authorized vaccination types are Pfizer and Moderna as Johnson and Johnson is no longer available following the recommendations of the Food and Drug Administration to pause Johnson and Johnson due to possible blood clots. Johnson and Johnson symptoms manifest anywhere from 6-13 days post injection. More details to follow on Johnson and Johnson. Ms. Yanez encouraged everyone to vaccinate, wear masks and social distance.

Boardmember Venencia provided clarification on the sign program in process as there are only 2 months remaining in this term and stated that moving it to the next fiscal year does not propose a problem for him as he can work with the provider.

Boardmember Hernandez inquired about the expenses of the previous board approved billboards and the \$10,000.00 expense as that is pending in the City Attorney's office for approval to pay that expenditure. Could this expenditure be reagendized for the next fiscal year and withdraw this proposal?

Boardmember Garcia stated that the delay in the City Attorney's Office is a severe handicap, effecting this determination and this board is no longer able to do anything as we will be over our retention budget.

d. Motion/Discussion/vote to issue Community Impact Statement for Public Bank LA. – By Adrienne Griffin (10 Minutes)

Vice-President Kahn made the motion to open this Item for discussion that was seconded by Treasurer Justice.

Ms. Griffin and Mr. Ben Gordon experience screen sharing difficulties with their prepared presentation and gave a verbal report assisted by co-host Vice-President Kahn sharing an email communication.

Ms. Griffin defined the benefits of utilizing a public bank and the functions of a public bank. Bank of (MBLA) Municipal Bank of Los Angeles underwritten by North Dakota Bank was introduced as their provider and their services were outlined to be a higher rate of return, reduction of bank fees, costs of projects, lower interest rates, and debt services. These reductions and recoveries would be directed back into the community. A public bank pays the city to put monies into Bank of North Dakota. They assist the community without issuing new bonds. Ms. Griffin and Mr. Gordon are requesting the Council draft a Community Impact Statement in support of introducing a Public Bank for Los Angeles.

President Avalos stated that Agendas Outreach Items were not posted correctly and that this information has not been provided to stakeholders for comments and questions.

Board member Morales inquired about the benefit of a CIS supporting a public bank for Pacoima and how does the CIS assist you?

Ms. Griffin stated that AB57 is in progress and the next stage is for the neighborhood councils to send a letter in favor of public government depositing funds. We are collecting the neighborhood councils from

different communities to come together. Our hope is the that public bank will be in communities and will be partnering with larger bank and assist small business. This is Public Bank Los Angeles and only for Los Angeles and there will be oversight.

Boardmember Morales asked if this will benefit somebody who wants to open their own business?

Ms. Griffin stated that government begins the process starting with the City of Los Angeles. The second state is partnering and secure different ways to expand and then be accessible to partner with credit unions or community banks.

Mr. Gordon stated that the allocation is one-third small business, municipal financing, and housing and energy infrastructure.

Boardmember Garcia verified with Vice-President Kahn that this information was emailed prior to the meeting and made available to stakeholders? What is the action today? The next meeting will be a new board and there will be no committees until post-election. Boardmember Garcia expressed his concern with the absence of correct posting and the stakeholders not being able to access what is being considered for a vote.

Vice-President Kahn agrees with Boardmember Garcia and we can table to next month or after the election.

Boardmember Hernandez asked when this Item was agendized for City Council.

Ms. Griffin informed the Council that the deadline is May 11th and would appreciate a support letter.

Boardmember Morales stated that this Item should be continued to a special meeting.
