New mask update, there has been a requirement of masking indoors regardless of having the vaccine or not to avoid transmission of the virus. There are over 1,000 cases per day and are from individuals who have not been vaccinated. They are urging everyone to get the vaccine as soon as possible. First pop-up vaccine site at Pacoima City Hall along with other community organizations and elected offices. Tacos El Gordo donated beverages and chips. At the first pop up, 174 vaccinations were administered. The second Vaccine will be back on July 31, 2021. Supervisor every year has a discussion on funding for nonprofits using funds and applying before the deadline on October 1, 2021.

### j. Department of Neighborhood Empowerment

Atzi Camarena: Civic Youth is coming back after a year due to COVID. It provides tools for neighborhood councils to understand the city government and partnerships with the mayor's office. The number of appointees cannot meet the majority of quorum. The first meeting for Civic youth is September 9, 2021 at 6:30 PM. Welcomes every new board member to the Neighborhood Council. Trainings for how to post on ENS, the Brown Act, 6:30 PM for all council board members. There are issues with Phishing emails asking for money. Do not open links and report them to Neighborhood Empowerment. With the rise of COVID and Delta variant, Councils are to meet virtually until December 2021. Meeting July 27, 2021 6-8 PM for financial officers.

Mark Ross: Neighborhood prosecutor assigned to Foothill Division. Officer Munguia covered some things already, as a neighborhood prosecutor there is one assigned through different divisions and work with the LAPD to decrease chronic problems and city agencies to see what we can do to deal with all the problems. There is a Los Angeles Municipal code 41.18 where you can't sit or lay on the street. If you have a law like that you have to have enough shelter beds before you can write them a ticket. No sitting or laying within 5 feet of a building entrance or 2 feet from a fire hydrant. This is a massive problem that needs to be approached from various levels such as substance abuse, mental health, etc.
