1. Discussion and/or Possible Action – The approval of a NPG for Comfort Zone Program in the amount of \$5,440. The program is 16 weeks to be held at The San Fernando Valley Boys and Girls Club in Pacoima. If approved the funds will be taken from the Annual Budget’s Outreach category.
2. Discussion and/or Possible Action – The approval of a NPG for Neighborhood Housing Services of Los Angeles in the amount of \$5,000 . The Pride Day event will be held on Saturday April 5, 2014. If approved the funds will be taken from the Annual Budget’s Outreach category.
3. Discussion and/or Possible Action –Creative Open Space L.A. is a project of the City of Los Angeles Department of Recreation and Parks that is working in only five Community Plan Areas of the City of Los Angeles, including Arleta-Pacoima. In Pacoima, we are working closely with Pacoima Beautiful’ s Urban Greening Project. Together, the two projects seek to capture the community's vision for open space and complete streets in Pacoima and provide a blueprint for city agencies, non-profits and others to act at various levels of involvement in this area that has very little open space currently.
4. Discussion and/or Possible Action – To purchase 500 PNC Magnets with contact information for all city departments in the amount of \$442. The strategy for the Pacoima NC is to increase brand exposure and interaction with our stakeholders. If approved the funds will be taken from the Annual Budget’s Outreach category.

The Board shall then refer the matter to the Grievance Committee, which shall have 10 working days to meet with the person submitting a grievance and to discuss ways in which the matter may be resolved. The Committee shall prepare a written report for the Board outlining their recommendations for resolving the grievance. The Board must then address the report at the next regular or special meeting. In the event that a grievance cannot be resolved through this grievance process, the matter may be referred to the Department of Neighborhood Empowerment for consideration or dispute resolution in accordance with the Plan. The formal grievance process is not intended to apply to Stakeholders who simply disagree with a position or action taken by the Board at one of its meetings. Those grievances can be discussed at Board meetings. This grievance process is intended to address matters involving procedural disputes, e.g. the Board’s failure to comply with these Bylaws, or its failure to comply with the City’s Charter, the Plan, or local, state, or, federal law.
